- Gala Day attractions
- Ground lighting

REGISTRATION & REFUND POLICY

Whilst we make every effort to find the right team for each player, there are times when this does not happen and de-registration is requested. The club incurs many costs at various stages throughout the season, and our refund policy takes the nature and timing of these costs into account.

The club's registration & refund policy is as follows:

- On registering with the club, a non-refundable \$100 deposit is required. The remaining amount must be paid before the first round of matches is played (unless a payment plan has been organised). **NO PAY, NO PLAY.**
- If the club has been unable to place a player into a team, a refund of 100% of the registration fee including the deposit will be paid.
- If the club places a player into a team and the player decides to de-register after the team list has been published, but before the start of the competition, the club will provide a refund of 75% of the registration fee (does not include the deposit).
- If a player de-registers after the start of the competition, but before Round 3, the club will provide a refund of 50% of the registration fee (does not include the deposit).
- If a player de-registers after Round 3 onwards, the club will provide **NO** refund unless the relevant committee director determines that a portion of fees can be refunded due to extenuating circumstance, with the approval of the Club Treasurer.

- Refund requests caused by exceptional circumstances (e.g. serious illness or injury, relocating of parent/s etc) may be considered by the Club committee on an individual basis
- Where a player's registration is withdrawn by the Club for breaches of the Casey Panthers Code of Conduct or any FV or FFA Code of Behaviour, no refund, regardless of other circumstances will be paid
- Registrations are not transferable between players
- Generally, any costs incurred by the club will not be refunded

Any request for refund of fees must be sent to the club in writing to the secretary (caseypanthers@hotmail.com) and will be forwarded for the attention of the Club Treasurer.

The Club Treasurer and at least one other committee member will evaluate the request and decide on the outcome.
